ORDINANCE NO. 220.77

ORDINANCE AUTHORIZING AND DIRECTING ADDITIONAL COURT COSTS  
FOR THE PURPOSE OF COSTS RELATED TO COURT FACILITIES

WHEREAS, the budget for the Commonwealth of Kentucky was enacted by the General Assembly during the year 2000 session; and  
WHEREAS, said budget for the Commonwealth of Kentucky was signed by the Governor on April \_\_\_\_\_, 2000; and  
WHEREAS, by the terms of said budget it will take effect upon signature by the Governor on April 25, 2000; and  
WHEREAS, said budget of the Commonwealth of Kentucky allows county fiscal courts to impose by ordinance additional costs relating to district courts, circuit courts and the sheriff's office; and  
WHEREAS, a copy of the express budget language which authorizes fiscal courts to impose additional costs is attached hereto and made a part hereof and incorporated by reference.

THEREFORE, IT IS HEREBY ORDAINED BY THE FISCAL COURT OF SIMPSON COUNTY, COMMONWEALTH OF KENTUCKY, pursuant to the FB 2000 - 2002 Budget Modification Report attached hereto:

- All items set forth in Section 10a(1), (2), and (3) of said Budget Modification Report are increased an additional \$25.00.
- All items set forth in Section 10a(4), (5), (7) and (8) of said Budget Modification Report are increased an additional \$10.00
- All items set forth in Section 10a(6) of said Budget Modification Report are increased an additional \$20.00.
- All items set forth in Section 10b(1) and (2) of said Budget Modification Report are increased an additional \$10.00.

This Ordinance shall be in full force and effect on the 1<sup>st</sup> day of July, 2000. Thereafter, the Clerk of the Simpson Circuit Court and the Simpson County Sheriff shall no later than monthly remit to the Simpson County Treasurer all the increased fees set forth herein. Said fees shall be expended by the Fiscal Court of Simpson County through the Simpson County Judge Executive for the purposes set forth in the FB 2000-2002 budget Modification Report.
