AN ORDINANCE RELATING TO AND APPROVING AN INTERLOCAL AGREEMENT FOR FIRE PROTECTION IN FRANKLIN AND SIMPSON COUNTY, KENTUCKY AND AUTHORIZING THE COUNTY JUDGE EXECUTIVE TO SIGN

WHEREAS, the City of Franklin and County of Simpson have reached an agreement with regard to the creation and operation of a consolidated fire department to be known as "Franklin-Simpson Fire Rescue" with the powers and duties as set forth in an interlocal agreement entitled "Interlocal Agreement for Fire Protection and Related Emergency Services between Simpson County Fiscal Court and the City of Franklin," a copy of which is attached hereto and incorporated herein by reference; and,

WHEREAS, the City of Franklin and County of Simpson require the passage of an Ordinance approving said interlocal agreement and authorizing the Simpson County Judge Executive to execute said interlocal agreement; and,

WHEREAS, it is in the best interest of the citizens of Simpson County that the County adopt this Ordinance.

NOW, THEREFORE, be it ordained by the Fiscal Court of the County of Simpson, Commonwealth of Kentucky, after the passage, approval, and publication of this ordinance as follows:

- 1. The Fiscal Court of the County of Simpson, Commonwealth of Kentucky hereby approves the terms and conditions of the Interlocal Agreement for Fire Protection and Related Emergency Services between Simpson County Fiscal Court and the City of Franklin, a copy of which is attached hereto and incorporated herein by reference.
- 2. The Simpson County Judge Executive is hereby authorized to execute any and all documents necessary and appropriate to effectuate the intent of this Ordinance and the Interlocal Agreement including, but not limited to, the Interlocal Agreement.

If any section, subsection, sentence, clause, or phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate distinct, and independent provision and such holding shall not effect the validity of the remaining portions.

All ordinances or parts so ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
