

AN ORDINANCE RELATING TO THE REDUCTION OF SPEED LIMITS ON CERTAIN COUNTY ROADS

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, COMMONWEALTH OF KENTUCKY, after the passage, approval, and publication of this ordinance as follows:

1. Pursuant to KRS 189.390 (5)(a), the speed limit for the following county roads is hereby reduced to 45 miles per hour:

Henson Road  
Chaney Road  
Phillips Lane

2. Pursuant to KRS 189.390 (5)(a), the speed limit for the following county roads is hereby reduced to 25 miles per hour:

Rutherford Avenue	Sean Drive
Clark Avenue	Winson Lane
Widener Circle	Salem Lane
Fairway Road	Monterey Drive
Nicklaus Lane	Hastings Drive
Palmer Lane	Lynn Way
Sara Way	Oakridge Lane
Eagle Drive	Honeysuckle Street
Boat Ramp Road	Hawthorne Street

3. Pursuant to KRS 189.390 (5)(a), the speed limit for Hatter Road, a county road, is hereby reduced to 35 miles per hour.

4. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
