AN ORDINANCE PROVIDING FOR THE UNCLEAN LOTS LOCATED IN SUBDIVISIONS IN SIMPSON COUNTY, BUT OUTSIDE THE CITY LIMITS OF THE CITY OF FRANKLIN, KENTUCKY.

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, KENTUCKY, that after the passage, approval and publication of this ordinance as follows:

SECTION ONE: UNCLEAN LOTS. Every lot or a part of a lot shall be kept free from stagnant water, or putrefying animals or vegetable matter or nauseous or offensive things and shall be kept mowed.

## SECTION TWO: CREATION, CONTINUANCE, ABATEMENT OF NUISANCES.

- 1. No person shall cause or suffer the creation of continuance of any nuisance. Nuisance shall include any act, place or conditions dangerous to health, or the failure to keep the lots mowed, or which in any way endangers public safety, peace, comfort or repose.
- 2. Any nuisance shall be abated by the person responsible, upon due notice by the sheriff's department of Simpson County. In case of failure to do so, after notice, the sheriffs department of Simpson County may abate the nuisance, and the county may recover the cost thereof from the person responsible for the nuisance.

SECTION THREE: PENALTY. Any person who violates any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be fined not less than \$ 5.00 or more than \$100.00 for each offense.

SECTION FOUR: In the event any part of this ordinance is declared uniforceable or unconstitutional, that said uniforceability or unconstitutionality shall not affect the remainder of this ordinance.
