

ORDINANCE NO. 910.4

**AN ORDINANCE ADOPTING THE AMENDED
COMPREHENSIVE PLAN FOR SIMPSON COUNTY
AS RECOMMENDED BY THE FRANKLIN-SIMPSON
COUNTY PLANNING AND ZONING COMMISSION**

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON,
COMMONWEALTH OF KENTUCKY, after the passage, approval, and publication of this
Ordinance, as follows:

WHEREAS, after a public hearing on September 4, 2007, and pursuant to KRS
100.197, the Franklin-Simpson County Planning and Zoning Commission approved an amended
comprehensive plan and submitted it to the Simpson County Fiscal Court for consideration and
adoption; and,

WHEREAS, it is in the best interest of the County to adopt said amended
comprehensive plan.

NOW, THEREFORE, BE IT ORDAINED by the County of Simpson,
Commonwealth of Kentucky, acting by and through its Fiscal Court as follows:

1. The amended comprehensive plan approved by the Franklin-Simpson
County Planning and Zoning Commission on September 4, 2007 is hereby adopted and all of the
provisions, conditions and terms of such amended comprehensive plan on file in the office of the
Franklin-Simpson County Planning and Zoning Commission are hereby referred to, adopted and
made a part hereof as if fully set out in this ordinance.

2. If any section, subsection, sentence, clause, phrase, or portion of this
Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction,
such portion shall be deemed a separate, distinct, and independent provision, and such holding shall

not affect the validity of the remaining portions hereof. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.


