

AN ORDINANCE CHANGING THE ZONING FROM
AGRICULTURAL DISTRICT A-1 TO HEAVY INDUSTRY DISTRICT I-2

WHEREAS, the Franklin-Simpson Planning and Zoning Commission held a public hearing on September 10, 1985, and as a result thereof recommended to The Simpson Fiscal Court that a parcel of land consisting of 17.81 acres located on east side of Blackjack Road and bounding Bob James on Blackjack Road on west for the purpose of constructing plant for manufacturing, metal fabricating to be located on east side of proposed access/connector road (1/3 of land on east side of proposed road and 2/3 on west side), be rezoned from Agricultural A-1 to Heavy Industry I-2 which is as follows:

That a request from J. H. Maupin & Associates, Inc., Howard Maupin, president, to rezone a parcel of land consisting of 17.81 acres located on east side of Blackjack Road and bounding Bob James on Blackjack Road on west, be rezoned from A-1 to I-2 for the purpose of future development.

As described in Exhibit A attached hereto and made a part thereof.

WHEREAS, it is deemed for the best interests of the Citizens of Simpson County, Kentucky that said Agricultural zoning classifications be changed;

NOW THEREFORE, BE IT ORDAINED by the Fiscal Court of the County of Simpson, Commonwealth of Kentucky that the property owned by Howard Maupin consisting of 17.81 acres located on east side of Blackjack Road and bounding Bob James on Blackjack Road on west for the purpose of future development.

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
