AN ORDINANCE CHANGING THE ZONING FROM  
AGRICULTURAL DISTRICT A-1 TO DEVELOPMENTAL D-1

WHEREAS, the Franklin Simpson Planning and Zoning Commission held a public hearing on March 3, 1987, and as a result thereof recommended to the Simpson County Fiscal Court that a piece of property located approximately 4 miles South of Franklin, South of Charlie Butts Road, .6 miles West of 31-W be rezoned from Agricultural A-1 to Developmental D-1 and shall be amended as follows:

That a request of Zeager Hardware Company to rezone the land due to changes of economic, physical or social nature within the area involved, approximately 250 acres 4 miles south of Franklin, south of Charlie Butts Road, .6 miles West of 31-W,

WHEREAS, the Franklin Simpson Planning and Zoning Commission realizes that there have been major changes of a economic, physical and social nature within this area and that it is deemed to be in the best interests of the citizens of Simpson County that said agricultural rezoning classifications be changed;

NOW THEREFORE, BE IT ORDAINED by the Simpson County Fiscal Court that the 250 acres located approximately 4 miles south of Franklin, south of Charlie Butts Road, .6 miles West of 31-W, be rezoned from Agricultural A-1 to Developmental D-1.

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
