## AN ORDINANCE ADOPTING ZONING MAP AMENDMENTS

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, KENTUCKY, after the passage, approval and publication of this ordinance, pursuant to KRS 100.211, that the following zoning map amendments recommended by the Franklin-Simpson Planning and Zoning Commission have been approved and adopted:

- (1) 84.25 acres, less 3 acres, in Simpson County, Kentucky, on Blackjack Road from A-1 (Agriculture) to I-2 (Heavy Industry) on the east side of Highway 1008 and to I-1 (Light Industry) on the west side of Highway 1008, pursuant to request by Southern Shotcrete, Inc.
- (2) Approximately 7 acres in Simpson County, Kentucky, located at KY 1008 West adjacent to Pennyroyal Nursery from A-1 (Agriculture) to B-2 (General Business), as requested by Miller and Son Builders, Inc.
- (3) Two tracts of land in Simpson County, Kentucky, located at the intersection of Highway 622 and Highway 100 (northeast corner and northwest corner), from A-1 (Agriculture) to B-2 (General Business), as requested by L. B. Travelstead.

This Ordinance shall take effect upon its passage, approval and publication. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
