AN ORDINANCE RELATING TO THE FRANCHISING OF CABLE TELEVISION

WHEREAS, the members of the Simpson Fiscal Court have received information from various sources concerning the enhancement of the health, safety and welfare of the general public by having available cable television service in those areas of Simpson County, Kentucky not heretofore otherwise provided such service; and

WHEREAS, pursuant to KRS 67.083(3)(s), the Simpson Fiscal Court is authorized to grant a franchise for such cable television service; and

WHEREAS, MW1 Cablesystems, Inc., a Delaware corporation, is a provider of such cable television service; and

WHEREAS, the Simpson Fiscal, after study and review, determines that it is in the best interest of the health, safety and welfare of the citizens of Simpson County, Kentucky to provide cable television service to those areas of Simpson County, Kentucky not heretofore otherwise provided such service.

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, COMMONWEALTH OF KENTUCKY:

SECTION ONE. Simpson County, by and through the Simpson County Judge Executive, is authorized to enter into an agreement granting MIN Cablesystems, Inc., a Delaware corporation, a non-exclusive franchise, affecting the territorial area as defined in said agreement, for the purpose of transmission and distribution of cable television signals available for sale to subscribers of its community television antenna service, and other various purposes, for a period of twenty (20) years from the effective date of said agreement.

SECTION TWO. The Simpson Fiscal Court resolution dated January 9, 1990, authorizing the County of Simpson, Kentucky to enter into the said Cable Television Franchise Agreement with MW1 Cablesystems, Inc. is hereby ratified and confirmed and adopted as a part of this ordinance as if set forth herein.

SECTION THREE. The provisions of this ordinance are severable. If any sentence, clause, section or part of this ordinance, or the application thereof, is for any reason found to be unconstitutional or invalid, such unconstitutionality or invalidity shall not affect or repeal any of the remaining provisions, sentences, clauses, sections or parts of this ordinance.

SECTION FOUR. This ordinance shall become effective immediately upon passage and publication.
