ORDINANCE AMENDING THE AGREEMENT ESTABLISHING A JOINT CITY-COUNTY
PLANNING UNIT, A JOINT CITY-COUNTY PLANNING COMMISSION AND BOARDS
OF ADJUSTMENT

WHEREAS, the Simpson County Fiscal Court and the City of Franklin entered into an agreement on the 9th day of December 1969, establishing a Joint City-County Planning Unit, and a Joint City-County Planning Commission and Boards of Adjustment;

AND

WHEREAS, said agreement has previously been amended by ordinances adopted by the Simpson Fiscal Court and the Franklin City Council;

AND

WHEREAS, the County of Simpson by and through the Fiscal Court and City of Franklin by and through the City Council have agreed that said agreement should be further amended.

NOW THEREFORE, BE IT ORDAINED by the Fiscal Court of the County of Simpson, Commonwealth of Kentucky, that the agreement ~~establishing the Joint City-County Planning Unit, Joint City-County Planning Commission and Boards of Adjustment shall be~~ amended in the following manner:

1. Section III - Joint Planning Commission - paragraph 2.C. shall be amended and shall read as follows:

"C. The Mayor and County Judge Executive shall appoint the members of the commission with the approval of their respective legislative bodies. The citizen members appointed by the Mayor shall be residents within the corporate limits of the City of Franklin and the citizen members appointed by the County Judge Executive shall be residents of Simpson County residing either within or without the corporate limits of the City of Franklin."

2. Section III - Joint Planning Commission - paragraph 2.D. shall be amended and shall read as follows:

" Commission members shall be appointed according to the following:

- 4 Citizen Members appointed by the Mayor
- 4 Citizen Members appointed by the County Judge Executive"

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
