AN ORDINANCE AMENDING THE SOLID WASTE MANAGEMENT BOARD REGULATIONS

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, KENTUCKY after the passage, approval and publication of the amendment, that same has been approved and adopted:

AMEND REGULATIONS AS FOLLOWS:

Section 1.00 would be changed to read as follows: 1.00 APPLICABILITY

These waste management regulations shall apply to the collection, generation, seperation, storage, transportation and disposal of all solid waste in Simpson County, Kentucky by all persons and shall apply to all waste disposal sites, facilities and landfills within Simpson County, Kentucky, whether such sites, facilities or landfills were open or proposed prior to or after the promulgation of these regulations, with the following exceptions:

This would add the "generation" in line 1.

- A new paragraph would be added to Section 1.70, named "L.", to read as follows:
 - L. Any entity generating solid waste in Simpson County shall promptly comply any request for information concerning said entity's generation of solid waste.

This ordinance shall take effect upon its passage, approval and publication.

To the Fiscal Court of Simpson County:

At the November 18, 1991 meeting of the Simpson County Solid Waste Management Board, the following changes to the Regulations:
