

AN ORDINANCE RELATING TO THE ADOPTION
OF THE KENTUCKY BUILDING CODE AS
PROMULGATED IN THE KENTUCKY ADMINISTRATIVE
REGULATIONS

WHEREAS, by Ordinance No. 940.0-1, the Fiscal Court of the County of Simpson, Commonwealth of Kentucky, enacted an Ordinance Relating to the Adoption of the Kentucky Building Code as Promulgated by the Board of Housing, Buildings and Construction of the Commonwealth of Kentucky in Title 815, Chapter 7, of the Kentucky Administrative Regulations;

WHEREAS, since the effective date of said ordinance, additional and/or revised provisions of said Kentucky Building Code have been promulgated in said Kentucky Administrative Regulations ("KAR");

WHEREAS, the Fiscal Court of the County of Simpson, Commonwealth of Kentucky, desires to adopt in full said additional and/or revised, as well as any future, provisions of said Kentucky Building Code.

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, COMMONWEALTH OF KENTUCKY as follows:

1. That pursuant to KRS 67.380, KRS 67.410 and KRS Chapter 198B, all buildings constructed in Simpson County, Kentucky shall be constructed in conformance with the Kentucky Building Code as set forth in Title 815, Chapter 7, or any other provisions, of the Kentucky Administrative Regulations now in effect, or hereafter

enacted, including any amendments to existing or hereinafter enacted provisions of the Kentucky Building Code.

2. That the Simpson County Building Inspector is appointed to administer said Kentucky Building Code in Simpson County.

3. That this Ordinance is intended to amend Simpson County Ordinance No. 940.0-1.
