ORDINANCE NO. 220.188

COMMONWEALTH OF KENTUCKY SIMPSON COUNTY FISCAL COURT

AN ORDINANCE RELATING TO THE COLLECTION AND DISPOSITION OF FEES BY AND PAYMENT OF COSTS OF THE OFFICE OF THE CLERK OF SIMPSON COUNTY, KENTUCKY

BE IT ORDAINED by the Fiscal Court of the County of Simpson, Commonwealth of Kentucky, after the passage, approval and publication of this ordinance, as follows:

- 1. Effective from and after September 1, 2016, all net income and net fees from the Office of the Clerk of Simpson County, Kentucky, shall be paid over to the County Treasurer, such payment to be on a monthly basis and not later than the 10th day of each month for the net income and net fees collected in the preceding month.
- 2. "NET INCOME" and "NET FEES" shall mean all unexpended income and all unexpended fees collected since January 1, 2016 less only applicable refunds to customers.
- 3. The expenses of and the expenditures by the Office of the Clerk of Simpson County, Kentucky shall be pre-approved and paid by the County Treasurer in accordance with the Purchase Order system adopted by the Simpson County Fiscal Court. Provided however; the Clerk shall certify to the Treasurer for payment each pay period, the names and hours of each employee of his or her office who worked during such pay period and the Treasurer shall pay such payroll without the necessity of any Purchase Order.
- 4. The Clerk shall draw no checks upon the Fee Account other than the check to pay over the net income and net fees of the Fee Account to the County Treasurer.
- 5. The Clerk shall be compensated at the maximum rate permitted by law.
- 6. This Ordinance shall become effective September 1, 2016.

7. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
