## **ORDINANCE NO. 920.77**

## AN ORDINANCE RELATING TO A ZONING MAP AMENDMENT

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, COMMONWEALTH OF KENTUCKY, after the passage, approval, and publication of this ordinance as follows:

1. The following-described property, consisting of 89 acres of land located on the east side of Franklin, on the north side of Highway 100, just east of the Exit 6 interchange on I-65 in Simpson County, Kentucky, is hereby rezoned from A-1 to B-5, and the zoning map shall be amended accordingly, as requested by John T. King, Jr., Executor of the Estate of H. E. Stradtner, pursuant to the recommendation of the Franklin-Simpson Planning & Zoning Commission after a public hearing on July 1, 2008:

Certain real property located east of Franklin on the north side of Highway 100, in Simpson County, Kentucky, to-wit:

Beginning at an iron pin in the north right-of-way of Highway 100 and east right-of-way of Eddings Road, being the southeastern corner of the subject tract, and common corner with Garvins; thence with the line of Eddings Road N 23° 30' 5" E 782.25 feet to a point; thence N 22° 44' 11" E 924.63 feet to a corner fence post in the right-of-way of Eddings Road; thence leaving the Eddings Road N 86° 38' 18" W 819.81 feet to a set pin; thence N 7° 56' 2" E 1,314.46 feet to a point, the northeast corner of the subject tract; thence N 85° 38' 31" W 887.72 feet to a point; thence S 8° 9' 20" W 351.78 feet to a point; thence N 84° 36' 15" W 643.50 feet to a point; thence S 9° 9' 45" W 1,334.52 feet to a set iron pin adjacent to a corner fence post; thence S 85° 35' 6' [sic] E 639.74 feet to a point; thence S 3° 23' 10" W 1,273.56 feet to a point in the north right-of-way of Highway 100, same being the southwest corner of the subject tract, common corner to Garvins; thence with the meanders of the north right-of-way of Highway 100 approximately 1,000 feet to the point of beginning, containing approximately 89 acres, more or less.

Being the same property conveyed to H. E. Stradtner and wife, Naoma Stradtner, and to the survivor, by R. E. Wear and wife, Anna Wear by deed dated January 3,

1964, of record in Deed Book 87, Page 184, Simpson County Clerk's Office. The said Naoma Stradtner died on the 6<sup>th</sup> day of January, 1997, leaving the said H. E. Stradtner surviving her and the full fee simple owner of the subject property. H. E. Stradtner died a resident of Simpson County, Kentucky, and by his will of record in Will Book 22, Page 429, Simpson County Clerk's Office, directed his executor to convert his entire estate to cash. John T. King, Jr. was appointed as executor of his estate by order of the Simpson District Court on September 4, 2007 in Case No. 07-P-00079.

2. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
