## **ORDINANCE NO. 920.79**

## AN ORDINANCE RELATING TO A ZONING MAP AMENDMENT

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, COMMONWEALTH OF KENTUCKY, after the passage, approval, and publication of this ordinance as follows:

1. The following-described property, consisting of 13 acres of land located approximately six miles north of Franklin on the east side of 31-W and the south side of Kentucky No. 1199, Simpson County, Kentucky, is hereby rezoned from A-1 to I-2, and the zoning map shall be amended accordingly, as requested by Larry Smith, President of Concrete on Demand, pursuant to the recommendation of the Franklin-Simpson Planning & Zoning Commission after a public hearing on September 2, 2008:

Being a certain tract of land located on the west side of US Hwy 31 W approximately 6 miles north of Franklin, Simpson County, Kentucky and being the tract that is bounded on the east by US Hwy 31W and bounded on the south by KY Road 1199, and more particularly described as:

Beginning at a stake in the southeast corner, a corner in the north right of way of KY Road 1199 and in line with the west right of way of US Hwy 31W; thence with the line of said west right of way N 21 d 30' E 451.44' to a post, a corner to the Mrs. Edna Cardwell Parcel; thence with the line of Cardwell, N 44 d 30' W 949.74' to a point in the east right of way of KY Road 1199; thence with the line and meander of said east right of way S 18 d 30' W 199.98' to a point; thence S 03 d 00' W 99.66' to a point; thence S 04 d 00' E 99.66' to a point; thence S 07 d 00' E 460.68' to a point; thence S 05 d 00' E 405.00' to a point and corner in the north right of way of KY Road 1199 that extends east to US Hwy 31W; thence with the line of said north right of way N 73 d 00'E 529.98' to the point of beginning, as per survey by E.C. Ellis in 1963, containing 13.0 acres, more or less.

Said parcel of land is also referred to as Tract IV of the Powell Potts Property in Plat Book 4, Page 11 in the Clerk's Office of the Simpson County Courthouse in Franklin, Kentucky, also referred to as Tract Number II in Deed Book 157, Page

646 in the Clerk's Office of the Simpson County Courthouse in Franklin, Kentucky.

Being the same property conveyed to Edward T. Hanks and Joy Beth Hanks by Powell Potts by deed dated June 4, 2001, of record in Deed Book 230, Page 525. Simpson County Clerk's Office.

2. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
