ORDINANCE NO. 920.80

AN ORDINANCE RELATING TO A ZONE CHANGE

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF SIMPSON, COMMONWEALTH OF KENTUCKY, after the passage, approval, and publication of this ordinance as follows:

1. The following-described property consisting of 0.748 acres of land located at 820 Blackjack Road, Franklin, Simpson County, Kentucky, is hereby rezoned from I-1 to B-4, and the zoning map shall be amended accordingly, as requested by William Spears and Nelson McDaniels pursuant to the recommendation of the Franklin-Simpson Planning & Zoning Commission after a public hearing on December 2, 2008:

TRACT I

Beginning at a set iron pin in the line of United Church, a corner to M & K, Inc., and located S 68° 40' 00" E 250.00 feet from a concrete monument in the east right-of-way line of Kentucky Highway 1171, which monument is a corner to M & K, Inc. and United Church; thence with the line of United Church S 68° 40' 00" E 324.76 feet to a concrete monument, a corner to United Church in the west right-of-way line of Kentucky Highway 1008; thence with foresaid right-of-way line two (2) calls: (1) S 23° 36' 33" E 39.94 feet, (2) S 02° 29' 06" W 44.03 feet to a set iron pin in the line of same, a new corner to Jim Traughber thence on a new line with Traughber N 73° 20' 46" W 368.40 feet to a set iron pin, a corner to M & K, Inc.; thence with the line of M & K, Inc. N 21° 19' 00" E 100.00 feet to the beginning point, containing 0.691 acre, according to May 15, 1997, survey of Robert G. May, Kentucky Registered Land Surveyor No. 2142.

TRACT II

A certain parcel of land located approximately 1 mile northeast of Franklin, in Simpson County, Kentucky, and more particularly described as follows:

Beginning at a concrete marker, corner to the United Baptist Church in a line 30' east of the centerline of Kentucky Route #1171, being the northwest corner of the described parcel; thence with the line of the United General Baptist Church S 68° 40' E 250.00 feet to an iron bolt, a new corner to Shotcrete, Inc.; thence with the new lines and corners to Shotcrete, Inc., S 22° 20' W 100.00 feet to a stake, N 68° 40' W 250.0 feet to an iron bolt, a new corner to Shotcrete, Inc. in the line 30' 00" east of the centerline of Kentucky Route #1171; thence with the line 30'

00" east of the centerline of Kentucky Route #1171, N 22° 20' E 100.00 feet to the point of beginning, containing 0.57 acre, less any easements or rights-of-way of record.

Being the same property conveyed to William D. Spears and Nelson McDaniels by Halon, LLC, by quitclaim deed dated August 13, 2007 of record in Deed Book 272, Page 739, Simpson County Clerk's Office.

2. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
