ORDINANCE NO. 310.16

AN ORDINANCE OF THE FISCAL COURT, SIMPSON COUNTY, KENTUCKY, APPROVING AN INTERLOCAL AGREEMENT FOR FIRE PROTECTION IN FRANKLIN AND SIMPSON COUNTY AND AUTHORIZING THE JUDGE EXECUTIVE TO SIGN

WHEREAS, the City of Franklin and County of Simpson have reached an agreement with regard to an extension of the agreement entitled "Interlocal Agreement for Fire Protection and Related Emergency Services between Simpson County Fiscal Court and the City of Franklin," a copy of which is attached hereto and incorporated herein by reference; and,

WHEREAS, the City of Franklin and County of Simpson require the passage of an Ordinance approving said interlocal agreement and authorizing the Mayor for the City of Franklin to execute said interlocal agreement; and,

WHEREAS, it is in the best interest of the citizens of Simpson County that the Fiscal Court adopt this Ordinance.

NOW, THEREFORE, be it ordained by Simpson County, Kentucky, acting by and through its Fiscal Court, as follows:

- 1. The Fiscal Court of Simpson County, Kentucky hereby approves the terms and conditions of the Interlocal Agreement for Fire Protection and Related Emergency Services between Simpson County Fiscal Court and the City of Franklin, a copy of which is attached hereto and incorporated herein by reference.
- 2. The Judge Executive of the Fiscal Court, Jim Henderson, is hereby authorized to execute any and all documents necessary and appropriate to effectuate the intent of this Ordinance and the Interlocal Agreement including, but not limited to the Interlocal Agreement.

If any section, subsection, sentence, clause, or phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate distinct, and independent provision and such holding shall not effect the validity of the remaining portions.

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

NOW, THEREFORE, BE IT ORDAINED by the Fiscal Court of Simpson County, Kentucky, that certain agreements entered into by and between the City and the County is hereby ratified and approved pursuant to the provisions of Ordinance No. 310.11, and an interlocal agreement for fire protection and related emergency services between Simpson County Fiscal Court and the City of Franklin is established.
