ORDINANCE REGULATING DISTANCE FROM POLLING PLACE FOR ELECTIONEERING!!

WHEREAS, the Fiscal Court has been requested to regulate the distance from the polling place (voting machines) where electioneering may be conducted;

AND

WHEREAS, there has been numerous complaints over the years that electioneering by candidates running for political office have been conducted too close to the polling place (voting machines);

AND

WHEREAS, the Fiscal Court of the County of Simpson, Kentucky, pursuant to KRS 117.235, has the authority to establish the distance from the polling place (voting machines) to where electioneering may be conducted;

NOW THEREFORE IT BE ORDAINED by the Fiscal Court of the County of Simpson, Commonwealth of Kentucky, that no electioneering shall be conducted within ONE HUNDRED FIFTY (150) FEET of the voting machines and this shall include displaying signs, the distribution of campaign literature, cards or hand bills, the soliciting of signatures to any petition or the solicitation of votes for or against any candidate or question on the ballot in any manner.

All ordinances or part of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
