During reports Magistrate Chandler brought up the discussion regarding the parks becoming a department of the county. Franklin City Manager Kenton Powell was present and suggested that the subject be put on the City's regular meeting's agenda for Monday, January 10th for the city's input on the subject. With Parks Director Terry Joiner's retirement coming at the end of January, the search for a new director is in progress which will be needed no matter what direction this discussion

County Attorney Sam Phillips reminded folks that 2021 property taxes are now late and come April they will become delinquent.

No one from the Jail was present since there has been a small Covid outbreak within the jail .

Magistrate Chandler reported that he had been contacted by an individual requesting that Elmore Gregory Road off of Rapids Road be added into the county road system. To be added to the system the gravel road would have to be brought up to county road pavement standards and the current estimated cost to do that is \$350,000. "No gravel roads shall be accepted into the County Road system" according to Ordinance No. 230.27, Simpson County Administrative Code, Chapter 5, Section 5.4, B.4. No record of this road ever having been included in the county system has been found but it had at some time in the past had a school bus turnaround. No action was taken on this request.

OEM Director Robert Palmer reported that he will likely be winding up his work with the Warren County OEM this week as he has been assisting there since the December 10°/11° tomado outbreak which led to massive devastation and loss of life. He expressed appreciation to Fiscal Court for allowing him to assist with the overwhelming task of damage assessment, cleanup and recovery efforts in Warren County since that weather event. He said that the experience has offered opportunity for him to learn ways to improve his plans for emergency preparedness. Yet another outbreak of tomadic activity on January 1, 2022, which according to the National Weather Service produced seven tomadoes in the region and locally caused the Community Outdoor Warning Signals to be set off. The signals located on Dogwood Drive and at the park did not function and Director Palmer has contacted Federal Signal Services for repairs and maintenance of this equipment. He reminded folks that these are outdoor sirens and not designed nor placed necessarily to be heard within structures but might sometimes be. He encouraged residents to have other forms of notification of weather events such as weather radios and phone apps since COWS can't be expected to provide warnings within homes, businesses or schools.
