County Judge Executive Mason Barnes called the fiscal court meeting to order and Magistrate Poston opened with prayer followed by the pledge to the American flag.

 Approve January 4<sup>th</sup> regular fiscal court meeting minutes.

 Authorize the amendment to the Kellwell Food Management contract with the Simpson County Jail which was originally approved January 5, 2021, with the terms of this amendment to begin January 22, 2022, for Option 1 with 3 hot meals and three staff on site with the difference in the price of going from Option 2 being 2 hot meals and 1 cold to be paid from the Jail Commissary and authorize the signature of Judge Executive Mason Barnes on the amendment.

Jailer Vaughn was asked by Magistrate Chandler to compile a list of wants including office and kitchen equipment that the jail wants to purchase with funds from phone commissions totaling \$67,000 to \$68,000 which must be amended into the budget with expenditures to be made at Fiscal Court's discretion. Jailer Vaughn will bring the list to the February 1<sup>st</sup> meeting. Funds leftover after purchases are made would go into the regular jail fund. The jailer also assured Fiscal Court that a certified trainer was present for the recent training that had been publicized.
