At a special-called meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, May 24, 2022, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order, and Magistrate Downey opened with prayer followed by the pledge to the American flag.

Pursuant to KRS 42.455 and KRS 174.100, Judge Barnes opened the public hearing, as duly advertised, for the County Road Aid (CRA) and Local Government Economic Assistance (LGEA) for public comment regarding use of the restricted funds from motor fuels taxes with FY22-23 projected revenue of \$882,553 and \$290,450 from LGEA funds from taxes levied on minerals mined in our county, mostly crushed stone. There was no public comment at this hearing, and it was noted that there had been none from phone calls or written comments to the County Judge's Office prior to this hearing. The hearing was closed.

Updates on several projects on state roads in Simpson County that have been approved, completed or near completion were given.

Judge Barnes reported that Collin Glover, a representative from Critical Infrastructure Security Agency, a division of the Office of Homeland Security, will be here this week to do an assessment of the county's cyber infrastructure at no cost to the county. Judge Barnes congratulated all 2022 graduates. He also called attention to information on the portal regarding plans for an Independence Day Parade this year. Consideration of some sponsorship of the Summer Vibes Music Festival will be on an agenda for a future fiscal court meeting. Another matter to be considered at a regular fiscal court meeting will be the question of the City of Franklin annexing Grace Road which is a county road within a development at KY 100 and Grace Road. The developer has already requested City annexation of the property where the business and residential development is proposed. He also presented copies of letters to the court that he had written as requested recently by Fiscal Court including one to Fish and Wildlife requesting the hunting zone assigned to Simpson County be changed to increase the deer limit.

Magistrate Downey reported that Boys & Girls Club board recently met and a committee has been formed to study the feasibility of the Bowling Green and Glasgow clubs merging with the Franklin-Simpson Boys and Girls Club. He announced that Jef Goodnight's Farewell and Appreciation event will be May 31<sup>st</sup> from noon 'til one at the local club as he begins his work with the Boys and Girls Club of America June 6<sup>th</sup>.

Magistrate Chandler announced that he and his family had worked with Tourism Director Amy Ellis to coordinate painting "Visit Franklin, KY" on the side of one of their barns that is clearly visible from I-65.
