At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, June 21, 2022, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order and gave the prayer followed by the pledge to the American flag. Judge Barnes asked that folks remember the family of former State Representative Wilson Stone who recently passed. He also welcomed John Chandler as the newly hired full-time building/electrical inspector on his first day.

Approve the minutes of the June 7<sup>th</sup> regular fiscal court meeting.

Proposed text amendments to the P&Z regulations suggested by P&Z Administrator Carter Munday were to restrict the construction of duplexes in an Agricultural Zone to one duplex per ten to one hundred-acre tracts which is the same as for mobile homes. Another recommended change was if a zone change recommendation and ordinance requires a development plan, activity implementing that development must begin within six months from the date the GIS has updated the map otherwise it will revert to its original zone and payment for associated costs for that zone change will not be refunded to the applicant. The consensus of Fiscal Court was to proceed with the process which will send the proposed amendments to the Planning and Zoning Commission and if passed there, come back to Fiscal Court by ordinance for official adoption into the regulations.

Fill material, removing and replacing mailboxes, and installing driveway intersection pipe shall be incidental to the bid. The cost of new pipe shall be quoted at a unit price per job.

6. Seeding & Protection: the bidder will seed and straw ditches & shoulders along various roads in Simpson County as directed by the County.

7. Pavement Striping - Permanent: The bidder will stripe various roads in Simpson County as directed by the County.

Judge Barnes reported that Ben Robinson of Kentucky Fish and Wildlife had responded to his request of the court to have the zone assignment for Simpson County changed from Zone 3 to Zone 2 which is the same zone as for all surrounding counties and allows for a higher limit of deer using a bow in addition to the limit with a gun. The board that officially makes that decision will not meet until sometime in August. He continued his report by commending the fire department for their handling of a major industrial fire at the CBD oil facility, Shyne Labs, on Reasonover Drive in the Wilkey North Industrial Park. The fire resulted in a total loss of the facility.

Magistrate Downey reported that seventeen teams will be involved in the Little League District Tournament at the Community Park June 25<sup>th</sup>-June 30<sup>th</sup>. The F-S Parks & Recreation will be a sponsor of the Independence Day Parade and movie nights at the park will begin July 9<sup>th</sup> at Lincoln Park and alternate with the Community Park through the summer for other movie nights. Art in the Park is hosted by Franklin Presbyterian Church every Thursday in June and July. He also reported that maintenance issues at the park are being addressed.

Magistrate Chandler made a motion to amend the County's Administrative Code to prohibit county employees from working for a vendor who provides services or goods to Simpson County, but the motion died from lack of a second.

County Attorney Phillips reported that delinquent tax bills are now at the County Clerk's Office and that his office has been doing contractual duty to collect those taxes and has sent 30 & 60-day collection notices. He encouraged folks to pay delinquent taxes now at the County Clerk's Office before the tax sale in August.

Jailer Eric Vaughn reiterated it is difficult to find employees willing to work for \$15 per hour. Considering the current maximum salaries for part-time jail employees having been set by Fiscal Court at \$15.00 an hour, Jailer Vaughn requested that a "specialty" part-time employee, who has been paid \$25.00 per hour as part-time IT, backup maintenance and for handling employee time sheets, be set up to be paid within a maximum annual salary of \$3,500 and issued a 1099 as is the practice of other contract employees currently working for the jail. He assured the court that the \$3,500 would never be met by this employee. During this discussion another matter came up regarding the fact that all current jail employee contracts should be amended to include that the contractor shall provide proof of insurance. No action was taken at this time but these topics will be revisited at the July 5<sup>th</sup> Fiscal Court meeting.
