At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, July 19, 2022, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order, and Attorney Sam Phillips gave the prayer followed by the pledge to the American flag.

Motion by Downey Second by Thurman Yes-All  
 Approve the minutes of the July 5<sup>th</sup> regular fiscal court meeting.

Motion by Poston Second by Thurman Yes-All  
 Approve entering into an agreement with Richard Jones of RJ Consulting Engineering, LLC for consulting services for Planning & Zoning and Public Works on an as needed basis with hourly rates of \$105 for engineering service and \$65 for AutoCAD Technician I with all costs recovered through the application process and fees through Planning and Zoning and authorize the signature of Judge Executive Barnes.  
 \*It was noted that the City of Franklin uses the services of RJ Consulting Engineering, LLC.

 Approve the FY22-23 Rural Secondary Flex Program recommendations of Eubanks Ford RD (CR1122), New Salem RD (CR1330), Calvert RD (CR1014) and Reames Dixon RD (CR1234) for resurfacing at an estimated total cost of \$203,952.00. \*These roads must be approved and inspected by KYTC.

 Approve the FY22-23 resurfacing projects on Stoss RD (CR1311), Charlie Butts (CR1213), Kenny Perry (CR1150), Vances Bill (CR1347) and Cedar Bluff (CR1042) for total estimated cost of \$405,609.00.

 Adopt the Resolution authorizing the Agreement between Kentucky Transportation Cabinet and Simpson County for construction of a drainage structure on Kenny Perry DR (CR1150) with \$80,000 from the CB01 Rural Secondary Fund and authorizing Judge Executive Barnes to sign the agreement.

 Authorize the proposal of Sheriff Hopson to fund four more school resource officers with additional funding provided by the school system with said funds to be paid to Simpson County Fiscal Court's General Fund and be earmarked specifically for school resource officer expenditures which will expand total SRO's to five and place one in each of the five Simpson County schools.

 Authorize a one-year extension with no changes to last year's detention center contract with West Kentucky Correctional Healthcare, LLC as recommended by Deputy Jailer Brent Deweese and authorize Judge Executive Barnes to sign the agreement.

 Approve amending the standing orders of the FY22-23 Simpson County Fiscal Court Budget to include the newly required County Clerk Permanent Storage Fee Fund as the county clerk has sole discretion for recurring expenses for supplies needed to support the requirements for the storage of permanent documents as established by Senate Bill 135.

 Authorize the transfer of 2010 F250 Pickup Truck (VIN 1FTNF2A57AEAD885) from Public Works (Road) to Planning and Zoning for the building inspector and of 2010 F250 Pickup Truck (VIN 1FTNF2A52AEA0888) from Public Works (Road) to the Animal Shelter.

 Approve cash transfer of \$21,253.46 from the Federal Grant Fund to the General Fund.
