Emergency Management Director Robert Palmer reported that Simpson County has been invited by Kentucky Emergency Management to move forward with the application to construct a Safe Room, which will be a storm type structure located at the community park, through the Hazard Mitigation Grant Program which is in the amount of \$600,000. The grant requires that the County will provide the 13% total match in the amount of \$78,000 with cash or in-kind work.
