County Judge Executive Mason Barnes called the fiscal court meeting to order with Sam Phillips opening with prayer followed by the pledge to the American flag.

Motion by Downey Second by Thurman Yes-All
 Approve the minutes of the October 4th regular fiscal court meeting.

Tammie Carey, Community Services Director with the City of Franklin, presented the court with detail on a walking trail project the city is working on and is requesting a section of county owned property be used as a parking area for the walking trail. The location will be at the corner of 31W and Hwy 1008 in behind Five Star. The city applied for a Recreational Trails Grant and was awarded \$97,000 for this project with intention to build a walking trail. This land is associated with the Goodnight and Hoy families of Simpson County. Tammie informed the court that there will be two parking areas with entrances off Hwy 1008 and Molly Ave.

P&Z By-Laws were presented to the court suggesting updates be made and that both bodies of government that oversee P&Z should approve the by-laws. Other suggestions included adding language to the by-laws relating to those serving on the P&Z Board be based on their residency. After changes are made to the P&Z By-Laws, Judge Barnes recommended both the city and county attorney along with the P&Z attorney review the updates to the by-laws.

Judge Barnes reminded everyone that Franklin BPW will host a political forum tonight at 6:00pm in the FSHS Cafeteria and that it is Business and Professional Women's (BPW) Week. He recognized women in this community and his appreciation for their outstanding work.

Judge Barnes announced that the joint city-county meeting will be at noon today, October 18th and Boo Fest will be Saturday, October 22nd. He also announced that the 4H Banquet will be November 3rd at 6:00pm in the Ag Building.

Magistrate Chandler informed everyone that voting starts November 3rd-5th at the Historic Courthouse and encouraged all to come vote.

Magistrate Downey reiterated that early voting will be at the Courthouse and not their previous precincts. He informed everyone that the Boys and Girls Club are looking for new board members since terms are expiring and anyone interested should contact them.

County Attorney Sam Phillips expressed his appreciation for Franklin BPW and the women in this community. He reminded everyone to pay their property taxes by end of this month for the 2% discount.

Maintenance Supervisor Bill Rohrs presented the court with proposals from three companies for a new door lock system due to our current system no longer having software available. Bill has been working with IT Operations Adam Wilshire to establish better security measures within the Historic Courthouse. The new door lock system would involve locking down interior doors as well as exterior doors. Bill recommended Company A and requested authorization to go ahead with installation of the door lock system on the east and west entry doors along with the main Judge/Executive Office door. The cost of any additional interior door will be \$2,999.20/each.
