Judge Barnes presented a thank you note from Good Samaritan Director Jason Gill for the recent additional one-time funding to assist with the ministries of Good Samaritan. He continued his report by announcing that according to the County's Administrative Code, Christmas and New Year's holidays this year will be observed on the Friday and Monday of each of those two holiday weekends. Judge Barnes, along with Fiscal Court, wished everyone happy holidays as the season of Thanksgiving and Christmas are upon us. He announced that a meeting hosted by the City of Franklin will be held Thursday, November 17<sup>th</sup> at 6 PM at the Cornerstone Building as the results of a recent survey are presented. The survey was conducted by a consulting firm to help develop a comprehensive plan for Franklin as the city grows. Judge Barnes announced that the Industry Appreciation Luncheon will be at noon December 6<sup>th</sup> at F-S High School with the culinary arts class preparing the buffet meal for the event.

Magistrate Chandler announced that the weekend Community Park Christmas Light Show will begin the Saturday and Sunday evenings (6-9 PM) after Thanksgiving and weekends throughout the holiday season on Fridays, Saturdays and Sundays. He said that Parks Director Lisa Deavers said that they have had good support from the community.

County Attorney Sam Phillips announced that the annual Lion's Club Pancake Breakfast will resume this Saturday after a couple of years off during the pandemic.

Public Works Director Bobby Groves acknowledged and expressed appreciation to Valley Ridge Concrete for the donation of concrete and dye for improvements to the pad anchoring the Christmas tree on the Main and Cedar streets corner of the courtyard. Public Works employees provided the labor for this project.

Regarding problems with the Autumn Lakes (previously known as Kennedy Lane) residential development, Planning and Zoning Director Carter Munday assured Fiscal Court that no building permits will be issued for any future builds in this development until corrections have been made.
