County Judge Executive Mason Barnes called the fiscal court meeting to order with Magistrate Poston opening with prayer followed by the pledge to the American flag.

Approve November 30, 2022 Financial Statement subject to audit and authorize signatures of Treasurer Nicole Law and Judge Executive Mason Barnes.

Judge Barnes thanked all who made the Christmas parade and other *Small Town Christmas* events possible. In his opinion this the third year for the community Christmas tree lighting had been the best yet. He announced that this year's Industry Appreciation luncheon would be held on this date at the F-S High School. His report continued with notice of a public meeting to be held at Salmons General Baptist Church Tuesday evening, December 13<sup>th</sup> as a "come & go" between the hours of 5:00 'til 7:00. KYTC District 3 Engineer Joe Plunk will conduct the meeting to discuss and answer questions regarding widening of 31W North between KY 1008 and Reasonover Drive.

Magistrate Downey, as Parks Board member, reported that the "Nights of Lights" at the community park has had over 1500 cars come through on the first five nights of the display which will be open every Friday, Saturday, and Sunday through January 1<sup>st</sup>. He also reported that there may be one final adjustment to the park's master plan and if an adjustment is made, it would be another week before a final drawing would be available. He continued by reporting that the Ag Building at the community park now touts that the kitchen there is now listed on the UK extension office statewide list of commercial kitchens available for rent. As Boys and Girls Club board member, he reported that their Christmas party for the children will be Tuesday, December 13<sup>th</sup> at 4:00 PM.

Magistrate Chandler reiterated the success of the Nights of Lights at the park and said that Tourism plans a Christmas lighting contest.

County Attorney Sam Phillips reminded folks that 2022 property taxes may be paid at face value through the end of the year and after that late fees will be added.

Judge Barnes also interjected that December 30<sup>th</sup> is the date set for the swearing-in of elected officials at the Justice Center.

Public Works Director Bobby Groves reported that Arnold Consulting Engineering Services has prepared an application to be submitted for permitting by the state "to construct across or along a stream and/or water quality certification" for the Kenny Perry low water crossing project. He also reported that patching and paving may be delayed this year as weather conditions have deteriorated and it may not be conducive to these tasks until spring.
