County Judge Executive Mason Barnes called the fiscal court meeting to order and Facilities Maintenance Supervisor Bill Rohrs led in prayer followed by the pledge to the American flag.

 Approve the minutes of the January 17<sup>th</sup> regular fiscal court meeting.

Motion by Thurman Second by Poston Yes-Burr, Poston, Thurman & Barnes Absent-Chandler  
 Approve second reading and final passage of FY22/23 Budget Ordinance No. 220.248, Amendment No. 4 in the amount of \$255,060.00.

Motion by Thurman Second by Burr Yes-Burr, Poston, Thurman & Barnes Absent-Chandler  
 Adopt Resolution authorizing the filing of a Kentucky House Bill (HB) 1 County Clerks election equipment grant application for up to \$40,800 authorizing and directing Simpson County Judge Executive Mason Barnes to execute any documents necessary by DLG to carry out the purchase of election equipment, specifically e-poll books.

 Approve the *Software as a Service Agreement* for inmate record keeping between Autonomy Today LLC, and Simpson County Detention Center at no charge for the first year and at a cost of \$1,000 less than currently paying JailCore after this one-year trial and authorize the signature of Judge Executive Barnes.

Jailer Vaughn reported that the jail will be adding a pilot radar technology system, Xander Kardian, which can monitor inmate's presence and some vitals from sensors initially to be mounted in six detox and medical cells which can signal an alert of a medical emergency to the control room monitors. The \$3,000 per device as well as any future charges or expansions of the system will be paid by commissary funds.

 Approve the January 31, 2023, Financial Statement subject to audit and authorize the signatures of Judge Executive Barnes and Treasurer Nicole Law.

Judge Barnes announced a ribbon cutting at ten o'clock following this meeting celebrating the expansion of Worldwide Technologies on Reasonover Drive. His report continued with the announcement of the \$260 million Trader Joe's Distribution Center project for Simpson County. The Chamber of Commerce Annual Dinner will be February 21<sup>st</sup> and the DLG Budget Workshop will be at the BRADD Wednesday, February 22<sup>nd</sup> from 9-noon. He asked Fiscal Court members to check the portal within a few days to review the proposed Cyber Security Policy to be added to the Administrative Code. He reiterated that the adoption of such policy is necessary to retain KACo cyber security insurance and the administrative code will be revised to include this policy.

County Attorney Sam Phillips reminded folks to pay their 2022 property taxes if they have not already done so. He also reminded the magistrates to have their monthly committee meetings to comply with that requirement.
