Judge Barnes announced that there will be a ribbon-cutting Thursday, June 22nd at the Community Park for the new pickleball and renovated tennis courts, that the July 4th Parade will be at 10:00 AM on the fourth, and that the next fiscal court meeting will be a special-celled meeting on July 5th. He continued by announcing the ribbon-cutting for Bluegrass Supply on Garvin Lane on June 27th and that the final Community Meeting for the Comprehensive Plan will be June 20th at the First United Methodist Church. He acknowledged a "thank-you" letter from F-S Project Graduation for the county's contribution. Judge Barnes shared a report from EM Director Robert Palmer that the radio communications tower installation has been delayed but should be in place by the end of July. He announced that he will meet with County Clerk Austin Johnson, Property Valuation Administrator Alison Cummings, and Facilities Maintenance Supervisor Bill Rohrs to discuss the first preliminary floor-plan drawing from the architect for the proposed Clerk/PVA building construction. A Juneteenth celebration will be held Saturday, June 24th at Lincoln Park, and he confirmed with Jailer Vaughn that inmates will take care of construction of the structure for the Life-jacket Loaner program.

Magistrate Chandler, an Ambulance Board member, announced that an appreciation luncheon would be held on this date at 11:30 honoring retiring Director Dale McCreary at EMS.

Public Works Director Bobby Groves presented guidelines to be considered by Fiscal Court when residents of Simpson County make requests for changes such as speed limits and signage. No action was taken but a more uniform system of requesting changes or additions to roads will be looked into.
