County Judge Executive Mason Barnes called the fiscal court meeting to order with Attorney Sam Phillips leading in prayer followed by the pledge to the American flag.

Approve Resolution #2023-07-18KPBridge adopting and approving the execution of Rural Secondary Program Agreement between Simpson County Fiscal Court and the Kentucky Transportation Cabinet, Department of Rural and Municipal Aid for the 80/20 Kenny Perry Bridge project for an \$80,000 maximum amount and authorize Judge Executive Mason Barnes to sign necessary documents.

Approve Grant Contract Regarding the Stone-Givens Industrial Development Area which allows the Franklin-Simpson Industrial Authority to receive 70% of the occupational tax collected by the County from all industry and business operated within this development area effective August 1, 2023.

Public Works Director Bobby Groves reported that he will meet Thursday morning with Scott & Murphy at Kenny Perry Bridge for a redesign from the original plans which called for wider approaches and dirt work that due to right-of-way constraints is not possible and along with that change not having to move the water line should deduct some from the cost of the project.
