Approve August 31, 2023 Financial Statement subject to audit and authorize signatures of Treasurer Nicole Law and Judge Executive Mason Barnes.

Judge Barnes thanked Kim Roberts, Amy Ellis and all who worked to help host the 60th annual car show and festival on the square this past weekend. He announced that due to staff schedules during Fall Break week the October 3rd Fiscal Court meeting will be cancelled and rescheduled as a special-called meeting on Tuesday, October 10th at 8:30 AM, and the next regular Fiscal Court meeting will be Tuesday, October 17th with the joint City County meeting at noon on the 17th at the Courthouse. Judge Barnes reported that County Clerk/PVA building site plans are available for viewing in his office and that Kentucky Senate President Robert Stivers will be at the Marriott Springhill Suites at The Mint at 8:30 AM Friday, September 22nd. The local Health Department will hold a ribbon cutting Thursday, September 21st at 10:00 AM after renovations have been made to the building. Judge Barnes's report continued with results of the recent A&M Consulting employee survey revealing that as of August 31st, 69 out of 93 employees participated in the survey, out of 38 employees at the jail, only 15 participated and that 80% of county employees agree that Simpson County is a great place to work.

As the result of the over \$842 million in Opioid Abatement Settlement funds allocated to Kentucky and with allocations to continue over the next several years an Opioid Abatement Advisory Commission has been established by Kentucky Attorney General Daniel Cameron. After having attended an Opioid Abatement Advisory Summit September 18th, Judge Barnes reported that there was discussion about the possibility of a drug recovery center within the BRADD. Unlike ARPA money, there is no timeframe to use this money, but it may only be used for opioid-related causes.

Public Works Director Bobby Groves responded to Magistrate Chandler's inquiry about the Kenny Perry bridge project by reporting that files were delivered the previous week and the project could start anytime within the next couple of weeks. He also reported that a factory representative for the recently acquired Mower Max Boom from ATMAX Equipment Company would be at Public Works for training personnel on this equipment the following day.

Authorize purchase of carpet and installation by A1 Floors for the first-floor hall of the Historic Courthouse at a cost of \$3,486.00.

Fire Chief Leslie Goodrum addressed Fiscal Court regarding full-time fire department proposals and associated costs. According to his figures, additional (over and above what is currently budgeted) revenue for two full-time per shift is \$384,527.49, for three full-time per shift is \$648,809.91, for four full-time per shift is \$913,092.33, and for five full-time per shift is \$1,104,294.22. Ideally because of the "two in, two out" standards required by OSHA and NFPA, the four full-time is the "at-least" preferred choice with the discussion that was held. There will be more conversations, and this will be a topic for discussion at the joint City/County meeting October 17th.
