County Judge Executive Mason Barnes called the fiscal court meeting to order with Magistrate Poston leading in prayer followed by the pledge to the American flag.

Approve second reading and final passage of FY23/24 Budget Ordinance No. 220.253 Amendment No.1 in the amount of \$146,162.00.

Approve easement granted by Dennis Cummings at 476 Robert Williams Road to Simpson County for the purpose of providing a school bus turnaround and authorize signature of County Judge Executive Mason Barnes.

During discussion regarding funding of a full-time fire department, Judge Barnes reported that he and Fire Rescue Chief Leslie Goodrum met with the Mayor Larry Dixon, City Manager Kenton Powell and one of the city commissioners last week. City has agreed and budgeted to equally share funding for two full-time around-the-clock along with the two on-call with stipend firefighters. The only way City would agree to more than two full-time is if there were a public referendum that demonstrated public support and the willingness of the public to agree to pay extra to have more full-time firefighters. The consensus of Fiscal Court during this discussion was to begin with this increase in personnel as at least a starting point. This will be on the regular joint City/County meeting agenda for consideration at noon, Tuesday, October 17th in the Courtroom of the Historic Courthouse.
