Judge Barnes asked Fiscal Court members to let him know their wishes about participating in the December 2nd Christmas Parade. He announced that there will be Veterans Day ceremonies at the Post Office at 11:00 and then another on the square at the bandstand at 3:00.

Authorize the complimentary one-week cyber risks assessment by Trinsio for all county properties as recommended by IT Department's Adam Wilshire and authorize Judge Executive Mason Barnes to sign any necessary documents.

*Since the County Clerk's Office is state connected, it will not be included in this assessment.

As the discussions regarding full time fire department progress, Magistrate Chandler would like to have a discussion with the city regarding the county transitioning to ownership of the fire department rather than the current lease arrangement.

Emergency Management Director Robert Palmer reported that the Alert Sense notification system for emergency preparedness information will be terminating and Everbridge will be providing notifications to Simpson County residents beginning December 1, 2023. Folks should watch for information regarding the transitioning to the new notification system.

Public Works Director Bobby Groves reported that the east half of Kenny Perry Bridge has been torn out and pipes were beginning to be set the previous day. Due to the discovery of some unexpected rock formation some of the plans for the approaches will require some adjustments but will result in a cost savings and some costs had already been acknowledged since water lines were not going to have to be moved as first thought. There will be no change in the structure of the bridge, only the approaches. He also reported that his department is pleased with the performance of the new MowerMax Boom Mower that was purchased in September.

Fire Rescue Chief Leslie Goodrum presented the request for consideration of an amendment to P&Z Regulation or an ordinance by requiring Knox Boxes to be required going forward with new builds for commercial and industrial structures with some thought of multi-family dwellings where there is a common area that accesses all interior individual units such as hotels or apartments. This box allows fire responders to have immediate access rather than having to wait for those on a call-list for entry into that structure and eliminates having to break down a door for entry. This would need to be a joint city and county decision. The consensus was to look at this proposal further

Chief Goodrum presented plans and details for the fire station renovation to accommodate the additional personnel are available on the portal and in this meeting's attachment file. The additional \$10,000 that was requested will be pulled from capital reserve. Demolition to prepare for remodel, electrical and internet will be handled in house and some construction will be contracted.
