At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, March 19, 2024, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order and led in prayer followed by the pledge to the American flag.

Jim Decesare was introduced as Franklin-Simpson Industrial Authority Interim Executive Director due to the recent resignation and departure of Executive Director Dennis Griffin who had held the position for twenty-five years.

Barren River Area Child Advocacy Center Assistant Director Chrissie Sherrard and Franklin City Police Detective Travis Frank gave an overview of the work that is involved in providing "protection, healing, and justice for child victims of sexual abuse in Simpson County". She reported that CAC provided services for 83 children in Simpson County in 2023. Due to substantial cuts in federal funding, Ms. Sherrard was requesting \$8,000 to maintain and fund services for Simpson County. This request will be considered as the FY24/25 county budget is prepared.

Milliken Chapel Road residents, Chip Willingham and Paul Zimmerman, were present and appealed to Fiscal Court for assistance in having a four-inch water line installed on this road. The Water District has given them a quote of \$150,000 for such a project and suggested that they come to Fiscal Court to make this request. Judge Barnes said that he would speak with Simpson County Water District General Manager Jacob Cuarta about this request as well as seek other resources or avenues for such a project.

\*It was noted that there is an error in the deed description within this ordinance specifically that Perdue Road is referenced in the deed description but should be Perdue Farms Road and on counsel of County Attorney Sam Phillips no correction was warranted at this time.

Approve February 29, 2024 Financial Statement subject to audit and authorize signatures of Judge Executive Mason Barnes and Treasurer Nicole Law.

Judge Barnes reported that some information regarding the budget time frame is on the portal for Fiscal Court as well as information about the STEAM Showcase at the high school. He called attention to the Triple M Land Farm permit renewal that may also be viewed on this meeting's portal.

Magistrate Thurman asked when Fiscal Court will have an opportunity to devote to the Comprehensive Plan and when Spurr Architect would have a design for the proposed Simpson County Clerk's building so that the process of obtaining bids can begin. No dates have been set for either of these matters.

Magistrate Burr reported that following the resignation of Ty Burklow as director of the Boys and Girls Club, Mark Dobbs will be serving as interim director. He asked if a rescheduling of the March 11<sup>th</sup> joint city county meeting has been set which it has not.

Judge Barnes did confirm that Fiscal Court will meet at its regularly scheduled first Tuesday of the month, April 2<sup>nd</sup> at 8:30 AM since County Attorney Phillips is the only Fiscal Court member scheduled to be out for the school spring break.

As a reminder Tire Amnesty Days will be April 25<sup>th</sup>, 26<sup>th</sup> & 27<sup>th</sup> and Judge Barnes said they will also work on getting another Scott Waste Amnesty Day(s) set up.

IT Specialist Adam Wilshire reported that the results of the free Trinsio independent cyber security threat/risk assessment of systems at the jail and at the Historic Courthouse are available on today's portal. Mr. Wilshire was asked to gather comparative figures and products/services between Trinsio and Cisco to present to Fiscal Court so that an informed decision can be made for the best cyber security protection by the April 2<sup>nd</sup> meeting.

Emergency Management Robert Palmer reported that Simpson County has been awarded the grant for phase one for engineering and design of the Safe Room at the Community Park. Once engineering and design work is completed then it will go back to the state for the next phase of the project. He also reported that the site of the radio tower at the Community Park is complete except for the generator and there has been a delay at the state in getting the frequencies nailed down through the FCC. Both Motorola and the contractor are hammering the state on why the delay. According to Mr. Palmer during the recent COWS (Community Outdoor Warning Signals) test two of the sirens failed and it could take months for the maintenance person to come here to diagnose and repair them.
