At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, May 7th, 2024, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order, and Magistrate Poston led in prayer followed by the pledge to the American flag.

Approve minutes of the April 30th special-called fiscal court meeting.

Approve Resolution No. 2024-05-07CRA adopting and approving the execution of the Simpson County Road Aid Cooperative Program Agreement between Simpson County Fiscal Court and Kentucky Transportation Cabinet, Department of Rural and Municipal Aid for the FY24/25 and authorize any necessary signatures.

Authorize County Road Aid Cooperative Program Agreement beginning July 1, 2024, with \$918,886.92 being this year's apportionment and authorize signature of Judge Executive Barnes.

Set the date of Tuesday, May 21, 2024, at 8:30 AM in the Courtroom of the Simpson County Historic Courthouse for the County Road Aid (CRA) and Local Government Economic Assistance (LGEA) hearing for proposed use of these funds and authorize advertising this hearing.

The FY24/25 budget discussion began at this point in the meeting. Since the April 30th special-called meeting, more numbers were available for the court to consider. Following this meeting's discussion, the consensus of Fiscal Court was to fund an additional one dollar an hour pay increase for employees of the Fire Department, Public Works, and Jail plus an additional \$5,000 annual contribution to Soil Conservation. As explained by Judge Barnes, for now, these options will be accomplished with an additional \$45,717 coming from cash reserves this one time and a \$19,446 reduction in asphalt during FY24/25. Options such as separating the Health Department as a taxing district or increasing the county's property tax rate could be considered for future revenue sources. A first reading of the FY2024/2025 budget ordinance is planned for the May 21st regular fiscal court meeting. Following approval of that first reading, it will be forwarded to the Department of Local Government for their review.
