At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, August 6, 2024, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order with Magistrate Poston leading in prayer followed by the pledge to the American flag.

Following a Presidential Disaster Declaration on July 25th for the Memorial Day weekend straight-line winds event, FEMA representatives, Yvonne Smith and Russel Anderson, were present to give a brief overview of how residents who had damages from this event could contact FEMA for assessment and possible financial assistance for damages and cleanup. Requests for assessments may be made online, by phone or in-person.

Approve minutes of the July 16th regular fiscal court meeting.

The first reading of a zone change ordinance was considered for a second time after Fiscal Court had considered it originally at the July 16th Fiscal Court meeting but could not reach a majority vote to approve that first reading of rezoning 10.393 acres of land along Witt and Cal Harris roads from Agricultural to Heavy Industrial. After considering information from the *Findings of Fact and Conclusions of Law and Approval and Recommendation of Zone Change by Franklin-Simpson County Planning & Zoning Commission* from the June 4, 2024, Planning and Zoning Commission meeting which had recommended the zone change, a motion by Magistrate Chandler and a second by Judge Barnes with no votes by Magistrates Thurman, Poston and Burr, the vote to approve first reading failed again 2-3.

Authorize purchase of Permit LV (Permit-Low Volume), a permit and inspections software management system for building and electrical permits, at a cost of \$14,724 for first year with yearly renewal at a cost of \$1,900 per year and authorize signature of Judge Executive Barnes as needed.

Upon recommendation of Fire Chief Leslie Goodrum, approve Resolution No. 2024-08-06EMP-FSFR to compensate Deputy Fire Chief Nelson Slaughter with an annual merit raise of \$2,100.08 effective with the payroll following approval of this resolution.

Rescind original Payments in Lieu of Tax Pilot Agreement with LioChem e-Materials, LLC which followed the SEEK formula originally approved December 19, 2023, and authorize signature of Judge Executive Barnes.

Approve updated Payment in Lieu of Taxes PILOT Agreement between the Simpson County Board of Education, Simpson County, Kentucky and LioChem, Inc. which is based purely on property assessment and taxes without the SEEK formula being involved and authorize signature of Judge Executive Barnes.

Approve Resolution No. 2024-08-06FLEX which adopts and approves the execution of Rural Secondary Program Agreement between the Kentucky Transportation Cabinet Department of Rural and Municipal Aid and Simpson County for funds amounting to \$136,943 for resurfacing of Barnes School Road (CR 1013) and Lake Springs Road (CR 1149) and authorize signature of Judge Executive Barnes.
