At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, October 1, 2024, at 8:30 AM

Present: Honorable Mason Barnes, Judge/Executive Honorable Jeffrey Burr, West Magistrate Honorable Marty Chandler, East Magistrate Honorable Scott Poston, North Magistrate Honorable Myron Thurman, South Magistrate Honorable Sam Phillips, County Attorney Nicole Law, Treasurer Pam Rohrs, Fiscal Court Clerk

County Judge Executive Mason Barnes called the fiscal court meeting to order and asked that those listening remember the family of twenty-one-year-old volunteer firefighter, Ethan Neal, who had lost his battle with brain cancer. He then led in prayer followed by the pledge to the American flag.

Amanda Guerra and Sara Kitchens with Kids on the Block, a children's educational puppetry group who have fifteen programs that address such topics as mental health, bullying, vaping and tobacco prevention, substance abuse and acceptance of differences were on hand to present information about their programs. The cost of a presentation is \$515 which helps cover puppeteer training and travel expenses. KOB can be reached regarding programs, donations and funding at 270.842.2259 or Kentucky Kids on the Block (kykob.org) website. They reported that last year they had presented programs to over 36,000 children with 309 programs in 35 counties in Kentucky including Simpson County elementary schools. Child Abuse Prevention programs are the ones presented most often.

Simpson County Tourism Director Army Effis reported that the 61st annual car show on Saturday, September 21st went well despite a rainy start to the event with 170 registered cars plus late-comers who were not registered. She expressed appreciation to Judge Barnes, volunteers, city and county employees as well as detention center inmates with most showing up at 4:30 AM to help close the streets and returned late in the afternoon to help cleanup. She continued by reporting that there were thirty-one vendors and several food trucks for the event and downtown merchants reported that they'd had one of the best days they'd had in a while.

Director Ellis gave an update on construction of the Tourism office at 105 West Cedar Street. There had been a problem with the old brick façade which had delayed the project. The drywall is now up, and painting is to begin this week. If the site passes inspection by the building inspector and the city engineer, hopefully, the sidewalk will be open by the end of this month.

Director Ellis continued by reporting that Tourism has used funds from a \$250,000 ARPA grant to create a traveler's itinerary phone app with twenty-one spots on a trail within the six key destinations of Simpson, Warren, Shelby and Harlan counties along with the cities of Georgetown and Corbin for a tourism initiative called Horses, Horsepower and Hollers. Another Tourism initiative, The Wild West of Kentucky Bourbon, is a campaign launching today to draw attention to smaller distilleries in western Kentucky including Simpson County's Dueling Grounds Distillery. The ARPA funds have been most beneficial for tourism in that it has provided the means to have professional filming for the marketing of Simpson County. Local ARPA funds received by Tourism have also made it possible for them to purchase nine user-friendly interactive touchscreen 7-foot kiosks which will be placed in hotels and other attractions with one to be placed outdoors at the downtown Tourism office with information regarding local restaurants, lodging and attractions. All should be in operation by the end of November.

Judge Barnes expressed appreciation to Tourism Director Amy Ellis and everyone that had a part in making the 61st annual car show day a good one. He reported that he will contact City Manager Kenton Powell to determine if there is a need to have the regular joint meeting which pursuant to Ordinance No. 120.02, would be at noon on the third Tuesday, October 15th at the Historic Courthouse. He also shared statistics from a recent economic webinar sponsored by the BRADD.

Magistrate Poston reported that the industries on Broadway have agreed to post signage to discourage commercial truck traffic on Broadway as discussed at the September 17th meeting. It had been determined that according to previous action such signage could be posted by a simple authorization by the Fiscal Court.

Magistrate Chandler reported he had talked with State Representative Shawn McPherson about the regional drivers licensing process. He reported that there is a program currently available that will provide counties with a local "hot spot" to allow renewal of license if public office space within the county can be arranged.

County Attorney Phillips reported that the 2023 tax sale was held last month and 2024 tax bills will go out this week. He encouraged folks to take advantage of the 2% discount if paid before November 1, 2024.

Sheriff Hopson, as the official responsible for tax collection, provided some information regarding the property tax process. Simpson County Property Valuation Administration is responsible for the assessment of property, which is done about every four years, and each of the six taxing districts - state, county, school, library, ambulance and extension - sets their rate. The tax bill total is calculated using the total of the assessed value times the tax rates for each taxing district. Judge Barnes interjected that 2.25% of the county collection is statutorily obligated to the Health Department. Any questions or challenges regarding an assessment must be discussed with PVA

A \$43,748.58 check from the Jail Commissary was presented to Fiscal Court to fulfill the obligation to Fiscal Court for FY24/25.

Paul Kelley was introduced as the newly hired facilities maintenance supervisor and has been on the job since September 18th.
