Tickets are required; if anyone wants to attend, they need to let Judge Barnes or Stacie in the office know. Judge Barnes received a letter from a resident in the Sherwood Terrace Subdivision expressing concerns and leading to the discussion of noise complaint ordinance in county subdivisions among the court. County Attorney Sam Phillips expressed his concern for the possible complaints that could arise from residents that live in the county but not in a subdivision. There has been an update to the Planning & Zoning Agenda for tonight's meeting, Housing & Infrastructure Committee presenting the idea of a new zone, which would be called R1C. Judge Barnes stated how he wasn't made aware a committee had been assembled, who the members are, how they are able to make recommendations to change regs, and what the potential zone R1C stands for. County Attorney Sam Philips suggested someone from the court attend the Planning & Zoning meeting tonight to ask questions about the proposed new zone. He also shared discussing this during the joint meeting with the city. East Magistrate Marty Chandler expressed road safety awareness to the public and emergency personnel.
