At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, January 21, 2025, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order with prayer, followed by the pledge to the American flag.

Motion by Burr Second by Chandler Yes-Burr, Chandler, Thurman, & Barnes Abstain-Poston
Approve the minutes of the December 17th regular fiscal court meeting, with the corrections to bills and claims: motion made by Burr instead of Poston and Chandler voted no, instead of abstaining.

Parks Director, Lisa Deavers discussed the proposed outdoor fitness court that would be open to a variety of ages, targeted towards adults. The fitness pad is built on a 38x38 (half of a tennis court) concrete pad with Regupol Athletic Flooring, placed in tiles. The flooring is low maintenance, once a year pressure washing cleaning and comes with a twenty-five-year manufacturer's warranty. The Parks Board would like to place the area close to the playground by the AG Building; parents would be in eye distance of seeing their children playing while working out. Judge Barnes suggested adding a quarter-mile walking trail around it, that would eliminate traffic interference.

The grant is awarded on a first-come, first-serve basis and approximately five per state each year receive it. They will start distributing in April/May, Ms. Deavers needs a letter of support from the city and the county for them to review and decide if Simpson County is a community they are willing to partner with for this grant. If rewarded even \$30,000, Ms. Deavers will still need to find \$120,000 in additional funding to cover the remainder.

Magistrate Jeffrey Burr asked what the difference between the fitness court and the studio. It was stated that the fitness court is just a padded surface with nothing on it. You can do yoga, outdoor workout classes on a softer surface, whereas the fitness studio has permeant workout pieces on it and a QR code that can be scanned for 30-minute workout sessions. The cost between the two courts is around \$100,000. Magistrate Chandler suggested using some of the money the court had set aside for the park to help offset some of the cost. The court decided to wait to find out what the letter of support entails before committing anything.
