At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, April 1, 2025, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order with prayer by North Magistrate Scott Poston, followed by the pledge to the American

Jailer Eric Vaughn asked how the County plans on handling the use of medical marijuana since the state legislature has legalized its use and the Simpson County Administrative Code has a clear policy set forth on how they handle alcohol and drug use by employees. Judge Barnes asked County Attorney Sam Phillips to put together a legal opinion based on the County's current administrative code and bring his suggestion back to Fiscal Court. Mr. Phillips has prepared a resolution that restricts its use in the workplace. Jailer Vaughn expressed concerns about if a county employee has a prescription to use medical marijuana and then get into an accident at work, protocol is for that individual to immediately get drug tested. He questions if the County could face a discrimination case if an employee's drug test came back positive and resulted in them being let go. Judge Barnes stated if an employee is prescribed medical marijuana, and they have their card we legally must allow them to take it but they wouldn't be able to work until it is out of their system and no longer using it.

Approve the Jail Medical Agreement (Comprehensive Correctional Care). There is an approximate \$8,800 increase from last year's contract. The Jail can't control the cost, due to the increase of insurance and medical treatments. The Fiscal

Acknowledge receipt of the proposed and prepared Jail Budget FY25-26.

Court is obligated and bound by the state to provide medical services to the inmates.

Judge Barnes stated that transfers in from the general fund revenue to offset the cost of the Jail is approximately \$100,000 difference from last year. Last year they budgeted 180 state inmates whereas this year they are budgeting for around 151. The Jailer is attempting to receive some other housing revenue from other local jails that are going through renovations and remodeling. If they can make that happen, everything will track in the right direction.

East Magistrate Marty Chandler asked the Jailer what the new line item was that had \$7,500 budgeted. Brent Deweese answered it wasn't a new line item; it's been there but they have noticed an increase in revenue from it. The Jailer commented there is a certain pool of money available every year on a first-come, first-serve basis. Once its depleted that's all, He said he knows County Treasurer Nicole Law is quick to get on it and he isn't worned about it. Just wanted to make the court aware of it. Magistrate Chandler also asked about full-time employees, Mr. Vaugh said they dropped two spots and replaced it with part-time employees to save the County money on insurance and benefits.

The County Treasurer was asked with one quarter of the fiscal year remaining, does she have some confidence that the Fiscal Court will not have to transfer in the entire amount that they budgeted. She responded, it's going to be close.

Approve the recommendation of P&Z Commission relating to prohibiting Biodigesters, with the addition of removal to section 5.

The Fiscal Court received information the Ptanning & Zoning Commission reviewed and analyzed over Biodigesters. Two options were presented, one being the acceptance of activity in an AG (Agricultural) Zone and/or Industrial Zone under certain conditions, while the other option was to prohibit the activity or the operation of such facility in Simpson County altogether. The commission ultimately voted in favor of prohibiting it. Judge Barnes stated he completely and fully supports the P&Z Commission Boards recommendation, and he encourages the court to vote to accept the option two that was presented.

County Attorney Sam Phillips said he was probably going to upset some people with what he was about to say but his job is to look after this body and the people of Simpson County from a legal standpoint. He doesn't believe the recommendation is a good idea, possibly exposing the County to a lawsuit where KaCo doesn't cover it. He is more in favor of restricting biodigesters and not prohibiting it due to legal issues.

East Magistrate Chandler stated he doesn't like the prohibition with an exemption. If you are prohibiting something that should be the end of it, not saying prohibiting it except under this condition. If you allow a small-scale farm to do it, then a neighbor starts to want to do it as well, then you get a bigger problem on your hand.

Concerned citizen Eric Vaughn expressed at what point do we take control of our community and say no we aren't going to do this.

Tammy Carey presented to The Fiscal Court the reason why the exception to allow small scale on farms was if there was a dairy operation that wanted to but a standarone digester on their farm to process manure that they had, and it was also mentioned that it is becoming popular for people to put small ones on their septic systems. She then proceeded to ask the County Attorney had he discussed this with City Attorney Scott Crabtree about wording change as this will need to be presented to City Commission as well.

Judge Barnes reiterated he supports the Planning & Zoning Commissions recommendation. He said there is a point in time when we've got to decide about what we want and don't want in our community and if we are sued over it, so be it. We will face that when we get there. He doesn't think as a governing body we should run away from fear of a lawsuit; it's our community and we should be able to prohibit what we want. If you don't like it, you're free to move to a different community. Term,

A citizen in the audience spoke about her daughter Madeline who has a traumatic brain injury from an ATV accident. Due to her accident she suffers from migraines and the site they are proposing the biodigester is close to her home. She is concerned that the increased odors, air pollution, and construction would trigger her daughters' symptoms. They have worked very hard to create a stable environment for her to help her recover and feel like this project would jeopardize that. She understands this project may have potential benefits for those directly involved but urges them to consider the impact on vulnerable individuals.

Judge Barnes told her the project that initiated this discussion has been completely taken off the table. Today is just to deal with this going forward in the future of what could or could not happen here.

Public Works Director Bobby Groves had questions regarding clarification of what all section 5 stated.

Judge Barnes reported FEMA is in the building for the remainder of the week helping people out who were affected by the February 15th flood and tomado. They are here Monday through Sunday until 7 o'clock in the afternoon. Bob Palmer is at the BRADD Meetings to discuss what he does in his CERT Team. Last week Judge Barnes sat down with all department heads talking about capital expenditure on the budget. Out of those meetings came about \$600,000 in capital expenses, and that does not include the ladder truck that the Fire Chief needs to replace. Monthly meetings over at the Clerks Building have continued. They are making a lot of progress, the drywall on March 20th was about 75th completed, painters are over there now, as well as utilities. The brick is on the back of the building and will continue to brick the rest over the next few weeks. Still anticipating be completed mid to late June.

East Magistrate Marty Chandler discussed that some communities require 3 years back taxes on property zoned from AG (Agriculture) to a different zone, at the amount it would have been taxed in the new zone. Judge Barnes believes when a parcel of land gets rezoned and it never pans out, he thinks the zone should revert to the original and if someone else wants to do something on it, it will need to go through the zone change process again.

County Attorney Sam Phillips, reminding everyone to pay your taxes, as of April 15th they will be considered delinquent, and you will no longer be able to pay them at the Sheriffs Office but at the Clerk's Office now.
