Sheriff Jere Dee Hopson – Please be aware of deer while driving. Property taxes districts are where the money is distributed. Rate set by Districts & PVA accesses every 4 years. Homestead exemption – 65 years of age or disabled – this is through the PVA office. Usually collecting taxes starts around October 1<sup>st</sup>, as soon as the Simpson County School Board turns rates in, we can start collecting. Usually start paying property taxes October 1<sup>st</sup>, but this will be moved closer to November 1<sup>st</sup> this year. Dates to pay property taxes are set locally but must be approved by the State.
